*\*Please refer to the IRS income tax regulations for the definition of who may qualify as a dependent child. If you're allowed by the IRS to claim someone as a dependent child on your income tax return, then this also qualifies them for LPRC purposes. Children who live in the same household and are married or do not qualify as dependents, per the IRS definition, are eligible to apply for a separate membership. See additional comments regarding adult children and married children under Seasonal Guests - NOTE below.*

**INDIVIDUAL MEMBERSHIP:** ..... **\$310**

**SENIOR INDIVIDUAL MEMBERSHIP (Age 60+):** ..... **\$230**

**SENIOR BASIC MEMBERSHIP:** ..... **\$260**

2 senior members, both must be 60+ years of age, and reside at the same address

**SEASONAL GUESTS:** ..... **\$95**

This fee is intended to cover each person who will be a guest of a member for all or a portion of the season. Included, but not limited to, are persons employed by the household for childcare purposes, children a member provides childcare for, grandchildren who visit for a short term, out of town guests who visit for the summer, etc. **NOTE:** Married children with or without dependents and adult children who reside with a member are not covered under the seasonal guest fee. Married children are eligible for a separate Basic Membership. Adult children are eligible for Individual Membership as described above.

**DAILY GUESTS:**..... **\$5 each**

Members are entitled to purchase guest tickets at the reduced rate of \$45 per 10 tickets throughout the 2006 season. **Recruit a new member and earn 10 free guest passes!**

**LATE FEE (not applicable to first time new members):** ..... **\$50**

Applies if active membership dues are not paid in full by May 1, 2006 or Inactive dues by July 1, 2006.

**WORK FEE (not applicable to first time new members):** ..... **\$75**

There are a number of projects that need to be done related to the pool, tennis courts and surrounding LPRC grounds. **This fee, assessed to every membership, will be waived if 4 hours of work per household is contributed toward a pre-approved LPRC work projects.** (All skill levels can be used). If your intention is to work off the fees, a separate check for \$75 must be included with membership dues. This check will be returned upon successful completion of the work hours. If you do not intend to work off the fees, please include the \$75 fee as part of your membership dues check.

**INACTIVE FEE:** ..... **\$110**

Shareholding members who opt to remain inactive for the year must pay this fee by July 1, 2006.

**WATER AEROBICS:** ..... **Free to members**
